





Curricular standard for CRIS systems


- 220.958 researchers

- ✓ Training services for national publishers.
- ✓ Public call for funding (MgG).
- ✓ National Advisory Board.
- ✓ National Open Science Committee.

- ✓ Standardize and improve current institutional publishing practices: European Quality Standard for Institutional Publishing (EQSIP) for IPSPs.
- ✓ Enhance the capacities of IPSPs
- ✓ Support policies and strategies in OA publishing by engaging with governments, RFOs, RPOs and policy-making bodies at their highest level of governance


